Councillors discussed the Hospital Transformation meeting attended by Cllr. E. Callear. It was felt to be very disappointing that the area would lose the A&E service. Councillors discussed the difficulty of parking at Shrewsbury Hospital. Cllr. D. Brown informed the Council that he had fed back the Wappenshall S.U.E. information to the Board Strategy Meeting.

# C23/167 FINANCIAL REPORT

Councillors discussed the traffic delays at rush hour on the Trench Lock interchange. Cllr. J. Keeble stated that the timings of the traffic lights is another cause of delay in this area. It was agreed that opening the Bus and Taxi Lane would enable a faster flow of traffic.

Cllr Jasmine Bennett proposed, Cllr. U. Ahmed seconded, all in favour of contacting the Highways team to discuss the possibility of opening the bus and taxi lane on trench lock interchange to all public vehicles.
